Acknowledgements

The concept for this manual was developed through both a series of consultations and also after years of assisting in family violence cases in the subcontinental communities.

Hon Marsha Thomson, Member of Parliament for Footscray, and Jasvinder Sidhu, Advisor to the Premier of Victoria Daniel Andrews, saw the need for a manual in 2012 as a response to a lack of understanding of the existing supports available to victims of family violence particularly amongst the Indian community. This came through clearly when they were dealing with people at risk of, or experiencing, family violence that were international students, new migrants or spousal visa holders in Melbourne's west and across wider Victoria. Thus the need for an easily accessible and user-friendly directory of available services to support community leaders in the Indian community was clear.

This idea was further developed into a tangible product by the Western Integrated Family Violence Committee (WIFVC) who helped create a template through community consultation, as well as assisting in data collection and research. We would especially like to credit Maureen Smith, Emma Breheny and Jacinta Masters for their work on this manual.

What this guide is for

This guide has been made for community leaders such as yourself because the community trusts you. People may come to you for help with problems in their relationships at home. Often they don't have anyone else to talk to about their problems, either here or back in India.

Family relationships are a very personal topic. When someone talks to you about their problems, it's important that you listen to them, trust them, and try to help them.

However, you will not be able to solve all their problems. Sometimes the best way to help is to find a professional who knows exactly how to deal with the situation at hand.

This guide will make it easier for you to find people the help they need in your local area. It's like a phone book or a manual, listing all the services a family might need, where they can find them, who can access their help and how to do this. We have divided this manual into areas of need to make it easy to use. Each area is colour-coded, to make it easier to find exactly what someone needs.

While all these services will try their best to help people in need, they are usually very busy and rely on few resources. The demands on their time mean they have to put in place criteria for who can and can't access their services. Some people without permanent residency will struggle to access services, however many services will do their best to help whenever they can. It is always worth making a phone call to explain the family's situation.

You can contact service providers on a woman's behalf initially if she is comfortable with this. She can also take a support person along to any appointments. This may make her feel more comfortable and confident attending that service. However, many services such as women's family violence services will want to speak to the woman alone to assess their situation.

INTERPRETERS

Most services can arrange interpreters if you let them know in advance. At the very least, they can organise phone interpreters to communicate with women who do not speak English very well. On-site interpreters must be requested when you make an appointment with the service. There is usually no cost to use an interpreter.

SPOUSAL VISAS

Many women who migrate to Australia do so on temporary spousal visas (visa subclasses 309, 820 or 300). This means that their spouse has sponsored them to migrate to Australia. A temporary spousal visa is put in place for 2 years, then the relationship is reviewed to see if it is still current and genuine. After that, a woman may be granted a permanent spousal visa (sub-classes 100 or 801).


Women who are experiencing family violence and hold a temporary spousal visa may be scared to leave their partner in case their visa gets cancelled. Sometimes their partner uses this to threaten them or force them to stay. However, there are special family violence laws available to women who have ended a relationship due to family violence whilst they were on a temporary spousal visa. If a woman has been granted a spousal visa, has applied for a spousal visa, or is eligible to apply for a spousal visa, she should be able to apply for family violence laws that will enable her to stay in Australia. Even without the spousal visa, depending on her circumstances, she may be able to apply to stay in Australia. If a woman returns to the relationship, her spousal visa status will continue as usual.

VISAS AND ENTITLEMENTS

People who hold a permanent visa ('permanent resident status') are entitled to almost all of the same benefits as an Australian citizen. This means they are given a Medicare card to access health services, they may work or study, they can freely travel to and from Australia and they can apply for Centrelink payments.

People on temporary visas do not have the same entitlements. Temporary visas are granted for a set period until a person's claim to reside permanently in Australia is assessed. Temporary visa holders cannot work, study or claim Centrelink benefits.

All women regardless of their visa status can access specialist information and support from their local family violence service and have the full support of the Police to protect their safety.




What is family violence?

The repeated use of violence or threatening behaviour towards any family member is considered to be family violence. Any family member can commit family violence including an intimate partner, relative or child. It is not just physical violence but also includes:

- + Making threats, for example to report someone to immigration if they tell anyone about the violence
- + Constantly criticising someone and demeaning them
- + Constantly blaming someone for things that go wrong, whether or not it's their fault
- + Not letting someone see their friends or family, or leave the house on their own
- + Controlling the finances, for example making her ask for money or taking her money
- + Not letting someone have access to a phone
- + Threatening to hurt other family members or pets


- + Forcing someone (including a partner) to have sexual intercourse when they don't want to
- + Forcing someone to practice a religion or not allowing them to practice one of their choice
- + Abusing children
- + Undermining the parent and child relationship in order to hurt the other parent

Family violence happens to women (and, less often, men) from all cultures and walks of life and there is help available.



Different forms *of* family violence

This wheel shows a **series of tactics** that are used to intentionally to **control or dominate a family member**. If you observe any of the below behaviour there may be a risk of family violence.





How will you know?

While you might feel like you have no business asking about what goes on in someone's home, there are a number of signs of abuse you should look out for. She may:

- + Appear nervous, ashamed or withdrawn
- + Seem anxious or uncontrollable in front of her partner/other family
- + Have a stress-related illness or symptoms of anxiety and depression
- + Have frequent, unexplainable bruises, cuts or broken bones
- + Children may be restless, cling to their mother, show bullying behaviours or attention-seeking behaviour
- + Seem scared or reluctant to make a decision without her partner

- + Not allowed to leave home alone
- + Not allowed to go to work
- + Not allowed to see family or friends
- + Have no access to money
- Have sleeping and eating disorders



Be aware

Women may be scared to tell anyone about the violence because

- + They will be abandoned by their family and community
- + They won't be believed
- + They will be separated from children
- + They have bad experiences with Police or Government agencies
- + The abuse may get worse
- + Their visa many be cancelled and they will be sent back to their country of origin

WHAT CAN YOU DO TO HELP?

It is important to be careful when approaching someone who you think may be experiencing family violence. You should gently approach them when they are on their own and maybe able to talk, but at no stage should you push them. Below are some questions that you might find helpful to ask:

- + How are things at home?
- + How are things between you and your family?
- + You seem very anxious and nervous. Is everything alright at home?

+ Are you concerned for your safety or the safety of your children?

If a woman does tell you about family violence, the following things should be kept in mind

- + Listen non-judgmentally
- + Show the woman that you believe her
- + Make it clear that the violence is unacceptable
- + Show support, whatever she decides to do, you are there to support her

It is very important for women to get help from professionals. When you suspect or know about family violence, DO NOT attempt to solve all the problems of the individual or the family. Refer them to qualified professionals who are experienced in dealing with the issue.

What Services are Available?

There are a range of support services available to help women, children and men who are having problems at home regardless of their visa status.

When a woman decides to get help from a service, she may need you to make the first phone call to explain her situation. This may be the first time she has told anyone what is happening so your support during this time will be critical.

You should be prepared that you may have to wait and there is the possibility that some services may not be able to help. Housing is particularly difficult to get, especially for women who are on temporary visas.

Police

If you are concerned for anyone's safety ring 000

Calls can be made anonymously.

When you call make sure you tell the police what is happening and the seriousness of it.

Police can be called day or night if someone feels they are in danger and needs immediate help. The police can take any action they think are needed to keep people safe including applying for an intervention order on behalf of the victims of violence to keep them safe.

If a woman goes to a police station to report family violence, no matter what time, the police can contact Women's Health West and a female worker will come out to them at the pvolice station

WHAT THE POLICE CAN DO TO KEEP FAMILIES SAFE

Family violence is a crime in Australia. Police take family violence seriously and will take action to ensure victims are protected. Remember, police in Australia are your friend when there has been family violence.

A family violence safety notice protects people, including children, from being hurt again. The family violence safety notice can protect the family before an intervention order application is heard in court.

 Police may issue a Family Violence Safety Notice straight away and set a date to appear at court. A Police Officer can apply for a safety notice even when the family will not want them to. This is because family violence is against the law.

- + Police will issue the safety notice, placing conditions on the person who has used violence. This may include, not contacting the person, not going to the house, or excluding them from the home. The safety notice provides protection for the victim until the court date, or 5 business days after the notice was issued.
- + If the police do not apply for a Family Violence Safety Notice and the victim believes there is a risk of further abuse, the victim can apply for an intervention order through the court. Like a Family Violence Safety Notice, an intervention order places certain conditions on a person who has used violence against their family. If the other person disobeys the intervention order; they can be charged by police. See the COURTS tab under the 'Applying for an intervention order' subsection for more information.

Police are the first service to call if you are concerned for a persons safety or if threats have been made. Victorian Police are qualified to work with victims of violence to keep them safe.

At every 24-hour station there is a Family Violence Liaison Officer who is a contact point between that station and the community. They can talk to you about any questions or concerns you have about incidents of family violence or the way police have responded to it.

If there is immediate danger, contact the police on **000**. In an emergency, you can contact the 24 hours / 7 days a week family violence phone line by **safe steps** on **1800 015 188**.

If a woman goes to a police station to report family violence, no matter what time, the police can contact Women's Health West and a female worker will come out to them at the police station.

Across Victoria there are services to help women who have experienced family violence. Each local area will have a family violence service that is available to all women in that area for support, counselling and information. These services can assist with many concerns including a place to stay, income and finances, help for children, court support and a long-term plan to stay safe. Across Victoria, there are also women's refuges that women can access through safe steps: Family Violence Response Centre. Some of these services may refer her to a women's refuge, which is a safe place for her and her children to stay

temporarily. Refuges are run by women who understand what she may have gone through.

Accessing safe accommodation and support may take time. Refuges only have a limited number of places and women without any permanent visa may struggle to get a place in a refuge. Often the services may only be able to provide a voucher for accommodation at a motel for a night or two before they can find anything more permanent.

Regardless of visa status, all women's services will try to provide whatever help they can. They will also refer women to other services if they can't help. It's always worth calling to explain the situation.

COURTS



Courts

Victims of violence or police can apply to The Magistrates Court for an Intervention Order to protect a family member from further harm.

An intervention order places certain conditions on a person who has used violence against their family. This might include not contacting the person, not hurting them or not going to the house. The intervention order is there to protect people including children, from being hurt again. Adults who have experienced violence can apply for it or the police can on their behalf.

Intervention Orders are similar to the Family Violence Safety Notice however it is a court order and it will last for longer.

If the other person disobeys the intervention order; they can be charged by police.

A court order cannot be broken. If it is, this is called a breach and it should be reported to police. A breach is an offence that carries a criminal punishment.

Children can also be protected under an intervention order.

To assist a woman to obtain an intervention order, you may take her to visit the local Magistrates Court or she may take someone else along with her. At the court, legal and women's services can help her through this stressful time. It can be confusing for people to fully understand their rights, especially when someone feels overwhelmed, which is why support is required and available.

Applying for an Intervention Order is open to everyone, including those on temporary visas. An intervention order doesn't mean that a family cannot live together, unless that's what the victim wants.

Other Legal Issues

When women have experienced family violence, they might be considering whether to stay or leave their husband or partner. They will want to know what their rights are if they and their partner separate, and whether or not to get an intervention order.

Apart from the issue of an intervention order, family violence can lead to other legal issues such as housing and tenancy disputes, access to children, or whether to start family law proceedings etc.

There are many legal services that can help by explaining what the options are, where to go for help and how to make sure everyone gets a fair outcome. Most of these services are free or low-cost. Some are especially for women and some are especially for migrant women. The first step is to phone the legal service the woman wants to use to make sure they can help her. They may ask her to come in for an appointment or they may arrange see her at court. Some services will also represent women at court.

Women may need assistance to get to these appointments and may feel more comfortable if someone goes with them.

Most community legal services will assist people on temporary visas.

For many women, speaking to someone who they feel they can trust is a useful way to understand what they are going through at home. Qualified family violence counsellors, who are always women, are available to talk to.

Seeking qualified family violence counsellors is very important. These counsellors are non-judgmental, informed about family violence, and will always listen to what a woman has to say. They can assist a woman to get further help if she needs it.

Counsellors can use interpreters for women who do not speak English very well. All counselling services are free or affordable.

Counselling Adolescents and Children

If a child or adolescent seems to be suffering distress following an immediate experience of family violence, they should see an understanding GP.

Family violence has a major impact on the health and wellbeing of children. Children who may be regularly exposed to family violence may suffer damaging psychological effects whether as a witness or as a direct victim. For instance, a child may not feel safe in an environment where they are aware that their mother may be in danger.

Other situations may also effect children, such as separation from a parent, having to change schools or move away from their friends

It is also very likely that family violence will have had a significant impact on the mother/child relationship, which can effect children's physical, emotional and intellectual development.

In the Western Suburbs, parents can access children's family violence counselling and support groups to help them deal with the stress of abuse. Support groups are suited to children up until the age of 12 years. However children's counselling is available up until adulthood. Some groups have strict eligibility criteria. Read these carefully to find out if the child you want to help will be eligible.

Housing

In Victoria, the law supports women to stay in the family home if that is what they prefer, and make the violent person leave. However, for many women, leaving is the safest and only option. This can lead to insecure accommodation and potential homelessness.

There are agencies that offer help in finding women and their children safe accommodation and, in the long-term, a home. Some of these agencies may refer her to a women's refuge, which provides temporarily, safe and supported accommodation for her and her children.

It's important to remember that these services are incredibly busy dealing with a wide range of people without a home.

Homelessness services will not always be able to help those on **temporary visas**, particularly those that have a long wait before they get permanent residency. In some cases, they may be able to provide rent assistance however these funds are usually in very high demand. Usually, they cannot assist with short-term accommodation for women who have a lengthy wait until they receive their permanent visa. **In these cases**, it is best to call women's services to see how they can help.

It's important to check whoever you are helping is eligible. A quick phone call beforehand can save lots of time.

These services are very busy. The advice that you give anyone who needs emergency relief is to arrive early and bring their documents with them (ID, proof of address, proof of income). Phone ahead for anyone who doesn't have any income so that you can explain their circumstances. The service might still be able to help you or they can refer you somewhere else.

Finances and Money

Centrelink is the first point of contact for income support. Centrelink is only an option for Australian citizens and permanent residents; for other financial assistance see the EMERGENCY RELIEF tab.

It is a common tactic in violent relationships that women are told false information from partners so that they do not leave the relationship. Women should be encouraged to meet with Centrelink to discuss their eligibility.

It is important to send women to Centrelink immediately. Women's crisis services will have access to Centrelink in the event of an immediate crisis.

Centrelink have social workers that help families who are experiencing a crisis, are in need of support, or are unsure how to access the right assistance. They are there to support families who are experiencing distress as a result of family and domestic violence, homelessness or hardship. For safety purposes, women can choose to go to a Centrelink office outside of their community. Call ahead to book an appointment.

There are also agencies that offer No Interest Loan Schemes (NILS) for purchasing essential items for their home or education expenses. Financial hardship must be proven to access the loans and there is

usually a time limit on when the loan can be repaid. If a person doesn't have any income at all, it's unlikely they will be able to get a loan because the agency must know they can repay it without going into more debt. When passing on this information to families, only give details of NILS agencies <u>listed in</u> this guide.

Financial counsellors are useful for those who are having trouble budgeting or staying on top of their financial commitments. If someone has never had to make decisions about income and spending before, a financial counsellor could be a great way to learn these skills. Financial counsellors can also help people that are in debt or facing bankruptcy by dealing with agencies or debt collectors, explaining a person's rights to them and helping them to avoid the situation in the future.

Only refer people to a free, government-authorised financial counsellor such as those listed in this guide. There are many services advertising a solution to debt and money problems. However, many of these are very expensive and lock people into contracts that leave them in a worse financial position. Call Financial Counselling Australia to find out where else free financial counsellors are located in Victoria: 1800 007 007.

Victims of family violence may be able to apply for a one-off crisis payment. To be eligible, a woman must be receiving or be eligible to receive a Centrelink payment on the day that she applies for the crisis payment. Victims must apply within 7 days of the family violence incident. Usually a police report is required. A woman must have either left the home due to the violence or the perpetrator must have left the home. There could be some flexibility around this.



The experience of settling in to a new country and making a new home can be difficult. There are many organisations that are staffed by experienced people who understand what migrants are going through and can help. If people need advice, help filling out forms, English classes, help finding employment or they want to connect with people from their own community, contact one of the organisations in this section of the guide.

Some women believe that they will be forced to return to their home country if they leave their abusive relationship. It is important to let the victim know that if they have experienced family violence they can still continue their application for permanent residency.

If a woman comes to you after being immediately physically assaulted you should take her, or arrange for her to be taken, to a hospital emergency department. Irrespective of the severity of the injury, it is important that the injury is documented with the hospital for evidence of the abuse.

When necessary, call 000 for an ambulance. The ambulance service is free for concession card holders, however it is very costly for those who do not have ambulance cover.

If a woman is emotionally distraught, the first point of call after police should be **WOMEN'S SERVICES** and **COUNSELLING** services.

Women can be supported by GP's who have acquired an understanding of family violence who can offer support and assistance.

A woman can go to a bulk billing doctor with her medicare card. If she does not have access to her card she can call Medicare on 13 20 11 to find their Medicare number details

Some community health centres offer a range of services from GPs through to mental health, nutrition or podiatry. Most of them bulk bill for services. Many of them try to help people with visa issues.

These centres are a good starting point when someone is trying to get help. They usually have strong connections with their local community and they know what other services can help with more specific problems.

Low cost dentists are also available at select community health centres and usually prioritise women who have experienced family violence and offer a reduced rate or free service.




Recovery from family violence is long and difficult. For victims to recover from family violence they need the support of family and community and the opportunity to connect to other people and lead active lives.

A critical part of this recovery is a woman being able to provide a safe environment for herself and her children. Knowing that she has this ability, it's more likely that she will avoid future situations of family violence or unhealthy relationships. There are many programs to help women find work or learn English, for free or at a low cost.

Support groups are another important part of a woman's recovery from her experiences. These groups can offer women improved social connections, a place to talk freely about their feelings and experiences without judgment, and a way of improving their own emotional and physical health. Community centres are a great way to engage with the community and learn more skills. They can have a wide variety of programs from language, arts, crafts, kids programs and so on. It can help women to build their confidence and self-esteem so they are not socially isolated. Community Centres are known by many names such as Community Houses, Living and Learning Centres and Neighbourhood Centres. These organisations provide social, educational and recreational activities for their communities in a welcoming supportive environment.

Every local area has one-on-one men's behavioural change counselling and Men's Behaviour Change programs that are run on a weekly basis for 3 months or more. The organisations that run these programs have been accredited and employ qualified staff. The most critical aspect of Men's Behaviour Change programs is an individual man's willingness to change his behaviour.

There is never any excuse for violence and/or abuse; but there may be factors contributing to that behaviour such as drug and alcohol use, mental health concerns or unemployment. Specialised services are available to assist men in these situations.

Men who are required to leave the home because of their violence may also be assisted with finding temporary housing. Centrelink crisis payments are also available to support men to fund temporary accommodation.
